This ambitious project had to have worried Amenemhat I because southern Canaan was a big source of supply. In order to protect Egypt, Amenemhat I built the Walls of the Ruler. One can notice that the area of Sodom was called Sutu[m] in execration texts (then Moab after 1800 BCE).
