The Impact of Harper & Row, Publishers V. Enterprises on Federal Appellate Court Decisions on Freedom of the Press Wang Jie, 2007 Abstract: In 1985, the Supreme Court ruled in Harper & Row, Publishers, Inc. v. Nation Enterprises that the Nation's unauthorized use of an unpublished manuscript of President Gerald Ford was not protected by the First Amendment's freedom of the press doctrine and was not a fair use under the copyright law. To rule on the fair use doctrine codified in the Copyright Act of 1976, the Court has to balance four non- exclusive factors set out in the Act. These elements are: (1) the purpose and character of the use, (2) the nature of the copyrighted work, (3) the amount and substantiality with respect to the work used and (4) the market effect on the original work. Given the fact that The Nation's use of the manuscript was for the purpose of news reporting, the manuscript was a factual work of high public concern, and

only 13% (300 to 400 out of 2250 words) from the published news were quoted from the manuscript, did the Supreme Court signal for a more restrictive approach to press freedom? This thesis aims to examine federal court of appeals cases after Harper & Row to evaluate the trend, if at all, in the appellate courts in response to the Supreme Court's opinion. Shepard's Citations was used to generate a list of cases citing Harper & Row. For the first part of the analysis, examined are five decisions involving news organizations are examined using judicial impact for guidance. All five cases were fair use cases. For the second part of the analysis, twenty more cases from the federal court of appeals which cited Harper & Row multiple times were examined to ascertain Harper & Row's impact on fair use decisions. It was found that Harper & Row's impact on lower courts was mainly through its interpretation and application of the fair use doctrine. The legitimacy theory explains the lower courts' compliance in general. The communications theory explains how the lower courts struggled to come to terms with the exact treatment of certain fair use factors. The utility theory was found to be better suited for the consumer population -- the litigating parties. Since the lower courts' treatment of the fair use doctrine showed a varied degree of divergence from the Supreme Court's approach, the impact of Harper & Row on lower courts' freedom of press decisions can been seen as minimally significant, although the symbolic impact of Harper & Row on freedom of the press escaped measurement of this thesis.
